

### **Executive summary**

In March, Utah county commissioners and Gov. Gary Herbert's public lands adviser met behind closed doors with oil shale lobbyists in Uintah County and local officials from Utah, Colorado, and Wyoming. Following the meeting, counties from those three states passed very similar resolutions demanding the Bureau of Land Management return to a radical Bush administration-era oil shale plan that puts western water at risk and locks-up two million acres of public lands for oil shale speculation. Newspapers, civic groups, citizens, and pundits from around the state condemned the meeting for violating sunshine laws. Just last week the Uintah County commissioner hosts finally admitted that they failed to properly notice the meeting and agreed to release the minutes and temporarily rescind their oil shale resolution.

Unfortunately, this sort of relationship between oil shale companies and politicians isn't new. For over a century, politicians have given millions of taxpayer dollars and public lands to companies engaged in oil shale speculation. In spite of this, industry has never been able to develop oil shale into a commercially viable energy source. Instead of learning a lesson though, politicians continue to throw good money and land after bad. We believe this kind of special treatment needs to end.

This document is an examination of why Utah politicians continue to give public money, to advocate for handing over public land to oil companies for speculation, and to do special favors for a failed industry.

We've divided our research into four sections. The first is an overall look at oil shale political contributions to federal, state and county officials. The second provides background on the pay-off of the Seep Ridge Road project. The third focuses on Red Leaf Resources, the political powerhouse oil shale company in Utah. The fourth examines Red Leaf Resources' quiet, foreign investor, Total S.A., a company with an extremely checkered reputation that has actively worked against U.S. security interests.

Thank you for taking the time to study this research, and for your help in ensuring that oil shale companies and politicians can't continue to operate in the shadows.

# Oil shale money in Utah politics

Oil shale interests have contributed \$45,550 to federal campaigns and \$43,600 to state campaigns since 2007.

### Federal Contributions

- Two energy companies supporting oil shale development and three oil shale lobbyists with ties to Enefit, EnergyNorthAmerica, and Bennett Consulting group contributed a total of \$45,550 to the Utah congressional delegation since 2007.
- Lobbyist Allen Freemyer contributed \$2,000 to Rep. Rob Bishop and \$3,000 to Rep. James Matheson. Freemyer is the lobbyist for Enefit and Oil Shale Exploration Company. Enefit compensates Freemyer \$20,000 quarterly to lobby for development of an oil shale project on public and private lands. Uintah County, where significant oil shale deposits are located, is also Freemyer client (2011 Lobbying Report, 4th quarter).
- Robert Weidner, a lobbyist for American Clean Energy Resources Trust (ACERT), contributed \$1,000 to Rep. Matheson. ACERT supports uranium exploration and mining. Weidner used to lobby for James W. Bunger and Associates (JWBA). JWBA "has been active in shale and tar sand development for more than 40 years and serve as consultants in this field to both government and industry" (Secure Fuels From Domestic Resources, September 2011). Bunger is a Senior Technology Consultant to Red Leaf Resources.
- Lobbyist Timothy Stewart contributed \$5,500 total to Reps. Matheson and Bishop and Sen. Orrin Hatch. Stewart is a managing partner at Bennett Consulting Group and a founding partner at EnergyNorthAmerica. EnergyNorthAmerica executive Jack Coleman was on the Energy and Minerals Counsel for the House Committee on Resources and was the author of the Oil Shale, Tar Sands, and Other Strategic Unconventional Fuels Act of 2005.

• As an attorney for Howrey LLP, Senator Lee represented Redleaf Resources, Energy Solutions. Compensated more than \$5,000 (Financial Disclosure Statement, 2010). Redleaf Resources is an oil shale technology company. He is also a director of Mazuma Capital. Mazuma Capital invests in the energy sector Financial Disclosure Statement, 2010). He sold his interests in Energy Solutions

stock but reported dividends between \$2,501- \$5,000 (Financial Disclosure Statement, 2010).

- Former Ambre Energy consultant Jonathon Reid contributed \$4,800 to Sen. Lee. Reid was also the campaign manager for the 2010 Lee Senate campaign. Reid is now a senior advisor to Utah Gov. Gary Herbert. Neither the company nor any other employees made campaign contributions.
- Anadarko Petroleum is a consistent and significant contributor in Utah federal elections having contributed \$29,250 to the Utah delegation.

#### State Contributions

- Three companies supporting oil shale development and lobbyist Timothy Stewart who is closely tied to the oil shale industry, have contributed a total of \$43,600 to statewide elected officials since 2007.
- Anadarko contributed \$26,500 to statewide elections; \$25,000 of which was a single contribution to Gov. Herbert in Jan. 2012 for his current campaign.
- Red Leaf Resources executives contributed \$16,000 to Governor Herbert.
- Lobbyist Timothy Stewart contributed \$500 to Gov. Herbert. The University of Utah is a client of Timothy Stewart's firm, American Capitol Group. The firm is compensated \$120,000 per year to secure "federal funding for priority University programs in research and development in DOE fossil energy and energy efficiency programs" (2011 Lobbying Report, 4th quarter). Researchers at the University of Utah recently secured funding through the DOE to study oil shale

### Local Contributions

- Oil shale lobbyist Allen Freemyer contributed \$250 to Commissioner Darlene Burns and \$250 to Commissioner Michael McKee.
- Oil Shale Exploration, now owned by Enefit, contributed \$1,000 to Commissioner Mark Raymond in 2008.
- Bob Williams is the largest contributor to all three commissioners, contributing a total of \$5,000. He donated the land for the USU Bingham Entrepreneurship and

Energy Research Center, which houses a large laboratory where Idaho National Laboratory, and "expects to demonstrate the integration of hybrid energy systems related to oil shale development with USU and industry collaborators."

# Seep Ridge Road – Oil shale subsidies in action

• Seep Ridge Road will service Red Leaf Resource's Seep Ridge oil shale facility, which has been put on indefinite hold. Despite that, this project was one of the only highway appropriations made but the Utah legislature.

The Utah Legislature began its 2008 session hoping to fund many new roads out of a large budget surplus. But when that surplus dried up, so did funding for most road projects. The final budget included little cash for new roads. Seep [sic] Ridge Road was one of the few exceptions. [...]

Sen. Kevin VanTassell, R-Vernal, who represents much of northeast Utah, got a \$2 million appropriation for seep Ridge Road via his seat on an appropriations committee. The money will be added to about \$2 million put up by Uintah County and a \$1 million pledge from industry to make up the estimated cost of preparing an environmental-impact statement and preliminary engineering drawings for an improved road.

• The Seep Ridge Road is set to extend 44.5 miles and cost taxpayers a total of \$85.5 million.

According to Cheri McCurdy, director of the Uintah Transportation Special Services District the entire project funding has been set aside

"The UTSSD obligation is \$30.5 million to be combined in three (phases) of funding from CIB for a total of \$55 million," she said. "It is anticipated to meet its Oct. 2014 project completion date."

Speaking to the UTSSD board McCurdy said the district has been offered an option for "a \$10 million grant and \$10 million loan at  $2\Pi$  interest loan" by the Community Impact Board to complete the third phase of funding for the project.

Several segments of the roadway are under construction with the exception of Segment I, which was completed in Nov. 2011.

# Red Leaf Resources – The force behind oil shale in Utah

### Red Leaf Resources Research Highlights

- Red Leaf Resources executives claim to not need government, yet its lobbyist says the industry needs "a little tax relief."
- Planned oil shale development by Red Leaf Resources will put a strain on the region's limited water resources, and other local services.
- Red Leaf Resources executives cite inconsistent numbers and predictions.
- Productions costs vary from \$25 to \$45 per barrel
- The staff and executives of Red Leaf Resources are politically well connected. They contribute to federal and statewide officials and have engaged federal lobbyists and Sen. Mike Lee's (R-UT) legal services.
- Red Leaf Resources contributed \$17,350 to federal campaigns and \$23,000 in Utah, including \$16,000 to Governor Gary Herbert.
- Red Leaf Resources does not report any spending on lobbying, at either the federal or state level. The company paid Dutko Worldwide \$110,000 in 2008. Although Red Leaf retains Jeff Hartley as its lobbyist in Utah, there are no financial disclosures reported.
- Red Leaf Resources has raised at least \$400 million from at least four sources. More than \$350 million has been raised since state regulators green-lighted a Red Leaf oil shale project in Utah.

# Red Leaf Resources executives claim to not need government, yet its lobbyist says the industry needs "a little tax relief"

• Red Leaf Resources Founder and Uintah Resources CEO Todd Dana said the domestic oil shale industry can compete with natural gas without subsidies.

"Unlike the Solar and Wind industries which cannot compete with electrical generation from natural gas without subsidies, the U.S. oil shale industry actually benefits from natural gas at low prices and without subsidies."

 Red Leaf Resources VP Laura Nelson is on the board of Environmentally Conscious Consumers for Oil Shale (ECCOS). ECCOS claims the oil shale industry uses no government subsidies. Oil shale is a market-driven industry, operating under strict environmental regulations and no government subsidies.

• However, Red Leaf Resources consultant and lobbyist Jeff Hartley says it makes sense to give a "little tax relief" to the oil shale industry.

- Red Leaf Resources is the beneficiary of millions in state and local money being used to build a "road to nowhere" that's only purpose is to provide all-weather access to their Seep Ridge facility where work has been indefinitely postponed.
  - o Uintah County has committed \$2 million to the road's construction.
  - o The Utah legislature approved a \$1 million appropriation for the road.
  - o Construction of the road has already begun, even though Red Leaf's Seep Ridge project has been put on hold.
- Red Leaf Resources was present at the meeting of state officials, county commissioners and oil shale lobbyists that occurred behind closed doors in Vernal, Utah on March 27. That meeting has been widely criticized by editorial pages and good government groups as violating the state's open meetings laws.
  - O At the meeting, language and strategy were discussed regarding resolutions subsequently passed that call on the BLM to reactivate the Bush-era oil shale plan.
  - o This plan would give 2 million acres of public land to oil shale companies for speculation, and drop royalties to bargain-basement rates.
  - O Those lower royalties would deprive Utah communities of the funds needed to expand infrastructure in the event that oil shale ever becomes a valid energy source, services including police, fire and schools.

### Red Leaf Resources activities could "out-strip" local water supplies

According to Laura Nelson, Red Leaf VP of Economic and Environmental Development, the EcoShale process uses almost no water (Utah *Business*, August 2011).

As for Red Leaf's "EcoShale" project development in Utah, company VP Laura Nelson said that their novel scheme uses even less water than Shell's - just one barrel of water for every five barrels of oil equivalent produced

Scott Ruppe, general manager of the Uintah Water Conservancy District, said Tuesday that if oil shale and tar-sands development increases steadily over the next decade to 20 years [near Vernal], then it could potentially out-strip the amount of water that would be available to users in the region.

If those companies were to eventually expand their operations and bring in thousands more workers and their families, then the resulting growth would put a strain on the area's water resources, Ruppe said.

### Federal and State Lobbying

Red Leaf Resources retained Dutko Worldwide as its DC lobbyist in 2008. Red Leaf paid Dutko \$110,000 for "[m]onitoring legislation related to energy and mining issues. Assisting client with legislative issues related to the commercial [sic] development of oil shale." Dutko lobbyist, William Simmons lobbied the U.S. Senate, the House and the Department of the Interior. Prior to joining Dutko, Simmons was the Staff Director for

the House Resources' Subcommittee on Forests and Forest Health. Dutko Worldwide no longer lobbies for Red Leaf according to lobbying reports. (Dutko Worldwide Lobbying Reports, 2008 and http://us.grayling.com/OurPeople/)

### Red Leaf retained the services of Senator Mike Lee

Red Leaf Resources is a former legal client of Senator Mike Lee. The company paid Senator Lee more than \$5,000 in compensation in 2009 for legal services, according to his financial disclosures.

Lee maintains a relationship with the company. He met with Red Leaf Resources executives on November 17, 2011. The same month, he submitted a letter of support on behalf of the company to the State of Utah. In the letter, he commended the company and wrote: "Red Leaf Resources is not only poised to deliver the benefits of new oil production, but also to deliver significant revenues to Utah schools" (Letter from Senator Mike Lee to Dana Dean, Utah Associate Director of Mining, November 28, 2011).

#### Red Leaf Resources has raised \$365 million since the end of March 2012

According to our analysis of public domain sources, Red Leaf has raised at least \$400 million from at least four sources.

In May 2010, Red Leaf Resources raised \$46.31 million of an anticipated \$50 million private offering through undisclosed investors (Financial *Deals Tracker*, May 13, 2010). TomCo Energy Plc invested \$5 million in Red Leaf's Utah project as part of Red Leaf Resources' attempt to raise \$100 million to fund "its joint venture agreement with a major international oil company" (TomCo Press Release, March 30, 2012). TomCo Energy Plc is a London based, public company with oil shale assets in the State of Utah (www.tomcoenergy.com).

Questerre has a joint venture agreement to participate as a 20% working interest partner in Red Leaf's Wyoming project. Questerre invested \$40 million in Red Leaf, representing 6% of the common equity. Questerre received a board seat on Red Leaf and appointed Michael Binnion, Chief Executive Officer of Questerre, to fill the seat (Questerre Press Release, April 4, 2012).

A Questerre press release confirmed that Red Leaf has entered into a joint venture agreement with a supermajor that "contemplates initially investing up to \$300 million"

(Questerre Press Release, April 4, 2012). Speculation of a supermajor investment in Red Leaf Resources began in November 2011 in an online article in the *UK Daily Mail*. A recent spike in the TomCo share price has been prompted by speculation that Red Leaf, which is mining the nearby Seep Ridge area using the same technology, is talking to one of the oil industry's majors, possibly Total. http://www.dailymail.co.uk/money/investing/article - 2057739/INVESTMENT-EX

"In 2003, the United States Securities and Exchange Commission (SEC) followed by the Department of Justice (DoJ) issued a formal order directing an investigation in connection with the pursuit of business in Iran, by certain oil companies including, among others, TOTAL. The inquiry concerns an agreement concluded by the Company with a consultant concerning a gas field in Iran and aims to verify whether certain payments made under this agreement would have benefited Iranian officials in violation of the Foreign Corrupt Practices Act (FCPA) and the Company's accounting obligations. Investigations are still pending and the Company is cooperating with the SEC and the DoJ. In 2010, the Company opened talks with U.S. authorities, without any acknowledgement of facts, to consider an out-of-court settlement as it is often the case in this kind of proceeding. Late in 2011, the SEC and the DoJ proposed to TOTAL out-of-court settlements that would close their inquiries, in exchange for TOTAL's committing to a number of obligations and paying fines. As TOTAL was unable to agree to several substantial elements of the proposal, the Company is continuing discussions with the U.S. authorities. The Company is free not to accept an out-of-court settlement solution, in which case it would be exposed to the risk of prosecution in the United States."

Total S.A. has also been linked to slave labor and human rights violations in Burma.

- The Yadana pipeline was constructed by Total through the 1990s in partnership with the U.S. petroleum company Unocal (which merged with the Chevron Corporation in 2005 and ended operations as an independent company), along with the wholly state-owned Myanmar Oil and Gas Enterprise (MOGE) and Thailand's PTT Exploration and Production Public Company Limited. (IPS (Latin America), October 5, 2007)
- U.S. media coverage focused on the involvement of an American company, Unocal, although the New York Times reported, "Unocal said, it is not even the biggest participant in the project, which is led by Total S.A. of France" (The New York Times, May 22, 1997).
